My name is Hilton Lewis Crawford. I am a white male 23 years of age. I reside at 660 Zavalla drive. I am employed by the City of Beaumont as a patrolman on the 12:00 midnight to 8:00 A.M. shift.

About 12:40 AM September 14, 1962 my partner I while on routine patrol in unit 213 turned left off of Lucas onto Pine St. About 50 yards from where we turned we saw a 57 Ford tunned sideways which was stuck in the ditch on Pine. As we walked up to the car we saw a negro man laying in the front seat. The doors were locked & the windows were rolled up on this car. We knocked on the windows and shined our lights in the windows. After about 5 minuets he woke up and we got him out of the car. Seeing that he was drunk we had him stand in front of us and touch his toes, and we pushed him into the ditch, We asked him to get out of the ditch and reached to get him. As he was getting out of the ditch he started to fall and we pushed him again. We yelled at him to get up several times. Seeing that this was not doing any good we punched him in the ribs several times just hard enough to wake him, because he had passed out. We did this because we did not want to stand in the water. After punching him and seeing that he was not coming to, one of us jokingly remarked that he looked like he was dead. I told Officer Corley that I would try tolget him out of the ditch with out us gettin wet. I fired my pistol into the ditch several feet away from him. I did this in an effort to wake him up, but it didn't work. We then had to get into the ditch to get him out. As we were doing this he woke up. into the ditch to get him out. As we were doing this he woke up. When we got him on the street we asked him if he had beat drinking. He said he had not. We could smell the alcohol on his breath and his speach was very impaired. We asked him to run about 10 yards and turn around quick. He did turn around and as he ran back toward us he fell down. I asked if he had been in the service and he said he was an Air-borne engineer, and he knew how to stand at attention and march. I told him that I had been in the Marine Corps and I wanted to see him march a stright line. He marched about 15 yards, then turned around and came back. During this time he was in a very staggering condition. We asked if he knew the air-force song. He said yes and began to sing it. He then told us that he worked at the Holiday Inn and if we would bring our own girl out there he would try to get us a room. We then placed him under errest for being drunk and asked which wrecker he wanted to come after his car. He would not answer. We then called for a no preference wrecker to come get his car because it was a traffic hazard. While we were waiting for the wrecker to get there, unit #9,0fficers came to see what we had. They and the wrecker driver observed this subject.
